

CHILD TRAVEL CONSENT — INTERNATIONAL TRAVEL (BOTH PARENTS CONSENTING)

- Emergency medical care;
- Hospitalization and inpatient admission;
- Dental care, including extractions and restorations;

This authorization extends to foreign hospitals, clinics, and licensed medical personnel at the destination. Reasonable efforts shall be made to contact a Consenting Party before any non-emergency surgical or invasive procedure.

Hague Convention on International Child Abduction. The Consenting Parties acknowledge the Convention on the Civil Aspects of International Child Abduction, Oct. 25, 1980, T.I.A.S. No. 11670, and its implementing US legislation, the International Child Abduction Remedies Act, 22 U.S.C. §§9001–9011. This Consent is intended to evidence authorized travel for purposes of the Convention. **US Customs**

and Border Protection. CBP guidance recommends that minors crossing US borders with only one parent or with a non-parent adult carry a notarized consent letter from the non-traveling parent(s). This Consent is designed to satisfy that recommendation. **Passport dual-consent principle (22 C.F.R. §51.28).** Both Consenting Parties represent that the Child(ren)'s passport(s) were issued in compliance with the dual-consent rule for minors under 16. **Destination-country requirements.** Entry and exit requirements for minors differ by country and change frequently. The Consenting Parties acknowledge responsibility for reviewing current requirements on travel.state.gov and the destination country's embassy website before departure.

Revocation. Either Consenting Party may revoke this Consent by written notice to the Accompanying Adult and, where applicable, to border or transportation authorities.
